



## Queeny Park

### HAYRIDES

Hayrides consist of a 45-minute tractor drawn hayride along trails in Queeny Park. Following the ride, a one-hour cook fire is provided. Reservations must be made in advance.

#### QUEENY PARK DIRECTIONS

##### PLEASE MEET ON MASON ROAD SIDE

To reach Queeny Park, take Manchester Rd. west 3 miles from 1-270 to Mason Road, turn right (north) on Mason Road and proceed 1 mile to the park entrance on left. The park entrance can also be reached by taking the Mason Road exit off of Highway 40, south for 2 ½ miles, turn right into Queeny Park.

**NOTE: There is no access to hayride site from Weidman Road- All permit holders must enter the park from the Mason Road side.**

#### INCLEMENT WEATHER

In case of inclement weather (lightening, heavy rain, ice) please call 314-822-1423 or 314-615-RAIN to inquire about cancellations.

#### HAYRIDE RULES

**Hay wagons hold a maximum of 20 people and a maximum of 30 people per fire pit area. (This is an actual count, regardless of age or size) and rides are available by reservation only.**

Please arrive 15 minutes early so your ride can begin promptly at the time stated on your reservation. No early set up at the fire pit areas is allowed.

All wagons must have at least one adult on board.

A cook fire area will be assigned **after** the hayride is over.

Food, drink or smoking will **not** be allowed on the hay wagon.

Firewood will be supplied to each assigned fire pit area, for a one-hour burn time for each reservation. You will be responsible for keeping the fire under control.

During periods of high risk of forest fire, a total ban on open fires will be enforced. When this occurs, every effort will be made to contact reserving groups, offering them the option of continuing their hayride without a cook fire, rescheduling (if available) or canceling and receiving a full refund.

Management reserves the right to cancel a hayride if any group or member of a group is intoxicated, unruly, or violates park rules or regulations. In such instances, all fees will be forfeited.

## **RESERVATIONS**

**Hayrides are available from April 1-May 31/September 1-November 30, on Friday and Saturday evenings at 6:00pm, 7:00 pm and 8:00pm.**

**Reservations are issued per wagon at a cost of \$150.**

Reservations may be made up to one full year in advance by calling 314-615-4386

Mon- Fri from 8:00am-4:30 or you may also reserve by visiting the Parks Department's main office or one of the Department's recreation complexes.

## **PAYMENT AND REFUNDS**

Reservations for hayrides must be paid at the time the reservation is made. Payment for reservations made over the phone must be paid for by credit card (MasterCard, Visa, Discover). Walk in Reservations (Recreation Complexes or Clayton main office) can be paid via charge card, check or cash. Upon payment, confirmation of your reservation will be mailed immediately along with a map of the park.

Partial refunds will be issued if notice of cancellation is received fourteen (14) days or more prior to the reservation date. The amount refunded will be the total amount you submitted minus \$20. **If our Clayton office receives notice of cancellation with less than fourteen (14) days before the intended use date, no refund will be issued.**

In case of cancellations by the St. Louis County Department of Parks and Recreation, we will either reschedule the hayride or offer a full refund. In case of cancellation by the St. Louis County Department of Parks and Recreation due to weather, please contact our Clayton office at 314-615-4386 within one (1) week of the cancelled date to reschedule or request a refund. There will be no refunds for no-shows or cancellation of wagons upon your arrival.

Date or time changes in hayride reservations may be made if notification of the desired change is received fourteen (14) days or more before the original reservation date. **An additional fee of \$20 per wagon will be charged to make the change.** If notice is received with less than fourteen (14) days before the original reservation date, the original deposit will be forfeited and a new charge assessed for the new date or time.
