1. Board Policies in regards to (Business & Law, 3yr) language.

### **1201015M:**

A Business and Law Examination shall be a required part of the qualification for Master License holders unless they have successfully completed the exam in the last three years. The examination shall test that the candidate has knowledge of business and law as it pertains to the privileges of a Master Licensee. The test shall include questions on contract, project, and financial management; tax and lien laws; insurance and bonding; business organization, personnel regulations, licensing, OSHA record keeping, and other similar topics as determined by the Board.

The Master Exams under the new testing agency has the Business & Law requirements included in the exams making them no longer separate tests.
